Funding Priorities

1. Meets an unmet or underserved need of young adults.
2. Grant applicants have the ability to implement the project.
3. Has vision for the future.
4. Organization has proof of tax-exempt status.

****The Sisters of Bon Secours Young Adults Ministry Grant Fund does not recommend a 'cap' on funding requests upon any individual proposal. Previous grant awards have ranged from \$750 - \$2000. The average award is \$1500. However, the total amount of funding available per cycle is \$7,000.**

Funding Philosophy

Support may be given to a grant applicant with the following stipulations:

1. Grants will be considered that allow the applicant to achieve their stated goal consistent with the mission and purpose of the Bon Secours Young Adults Grant Fund;
2. Priority will be given to start-up ministries, service development, operational support and capacity building.
3. Applications will be considered that meet the grant deadline.
4. Acknowledge support of Bon Secours Young Adults in your promotional materials in return for grant support.
5. Funds must be utilized by June 30, 2020. Unused monies shall be returned to the Grant Fund.
6. Recipients will submit report upon completion of project detailing how grant was utilized.

1. **Project Description:** Please describe your project and the organization to which it belongs. How does this request/project connect with the faith, community, and service of young adults? How does it further a part of the Bon Secours Charism of Compassion, Healing, and Liberation in the world?

3. **Project Goals:** List the goals and specific objectives of this project and provide an estimated timetable for implementation.
4. **Budget:** What are the specific itemized uses of the grant funds you are requesting?
5. **Project Sustainability:** Are there long-term plans for continuing this project?
